

## SPSS Licence – Staff Home Use Agreement

**Murdoch University** ("Licensee") has licensed the SPSS software from **SPSS Australasia Pty Ltd** ("Licensor"). By installing, copying or otherwise using the Software, you agree to be bound by the terms of this Site License Agreement ("Agreement"). If you do not agree to the term of this Agreement, you must not install the software.

Issues relating to the regulation and appropriate use of this software must be managed at a Division or School level. Divisions or Schools may find this form helpful in promoting the responsible use of these products under the 'home use' licence provision. Completed forms should be held by the Division or School, and a copy given to IT Services and the employee.

Before installing these products on personally owned or leased workstations, staff should note the following:

1. Software is only to be used for Murdoch University for teaching, administrative and research purposes. Full conditions available at <http://www.its.murdoch.edu.au/license/>
2. Staff using this software on personally owned or leased workstations do so at their own risk. Murdoch University will not accept any responsibility or liability for any consequential damage or lost data resulting from the use of this software.
3. Staff undertake to comply with copyright laws and understand that severe penalties apply to persons who do not comply with software licence provisions.
4. Copies of this software media and/or the ability to use these products must not be passed to persons who are not employed by Murdoch University.
5. Staff electing to use these products on a personally owned or leased workstation must undertake to remove this software from any such workstation on disposal of the equipment, termination of the Site License Agreement or termination of employment with Murdoch University, whichever occurs first.
